Eviction Prevention Services

A Notice of Eviction is a document produced by a sheriff or marshal after a court has authorized a tenant's eviction. A marshal or a sheriff may send the notice by mail, deliver it in person, or post it on the tenant's door. The paper says "NOTICE OF EVICTION" at the top and includes the name of the court, the marshal or sheriff's contact information, a Docket Number, and an Index Number.

If you receive Cash Assistance (also called Public Assistance), you may be eligible for help paying your back rent.

Seniors who have received a Notice of Eviction or a written notice from their landlord can get eviction prevention assistance and legal referrals. The City also provides eviction assistance for seniors age 60 and older who are mentally or physically impaired.

The City offers the One-Shot Deal Program to those who qualify. Families and individuals with rent arrears who may be at risk of eviction can apply for One-Shot Deal rent assistance.

The One Shot Deal is a one-time emergency grant to help people who can't meet an expense due to an unexpected situation or event.

The "One Shot Deal" emergency assistance program helps people who can't meet an expense due to an unexpected situation or event. Emergency assistance is provided for, but not limited to, the following situations:

- Homelessness
- Dispossess/Eviction
- Utility disconnected or pending termination
- Fire disaster
- Domestic violence
- Circumstances that affect the health and safety of the individual or family

- Household income range between \$15,000 and \$30,000 annually
- An eviction petition has been filed
- The household has the ability to pay rent in the future.
