Transportation Advocacy Update

At the most recent meeting of the MTA board, CIDNY's outreach drew many people with disabilities from both CIDNY and partner organizations, including [AHRC](#) and [Rise & Resist](#). Transit President Andy Byford presented a new plan, "Fast Forward: The Plan to Modernize New York City Transit." It discusses improving bus and subway service for people with disabilities. Improving Access-A-Ride was also discussed.

CIDNY, a member of AARRG!, was pleased co-sponsor an Access-A-Ride forum with NYC Councilwoman Carlina Rivera on May 15th, in which 23 of her constituents participated. Users and advocates spoke about the importance of Access-A-Ride to their lives, but also the need to improve the service. Many were concerned about the eligibility review. Some experienced denials based on Access-A-Ride overriding their doctors' letters that stated how their disability affected their ability use public transit.

CIDNY also participated in NY State Senator Brian Kavanagh's Community Convention. Hundreds of his constituents attended. The issues presented mirrored many of the concerns you raise to us. For example: rights in transportation (subways and Access-A-Ride), tenant and public housing rights, the importance of affordable and accessible health care, and the lack of elevators in the subways. Legislative Disability Awareness Day

On May 30, 2018, 25 CIDNY participants and staff went to Albany to participate in New York State Assembly Legislative Disability Awareness Day to advance our policy priorities. CIDNY consumers shared their stories and discussed policy issues with staff of Assembly Members Steve Englebright, Dean Murray, Harvey Epstein, Charles Lavine, Jaime Williams, David Gottfried, Edward Ra and Senators Joseph P. Addabbo, Jr., John Flanagan, Brian Benjamin, Andrew Lanza, Brian Kavanagh, Jeff Klein, John Brooks Jamaal T. Bailey, and Chris Jacobs.

While we were there, the Assembly passed a legislative package that includes some of the policy issues that CIDNY advocates have lobbied on, including:

- Re-establishing the Office of the Advocate for People with Disabilities;
- A waiver of the state's sovereign immunity to claims under the ADA, the Age Discrimination Act of 1967, the Fair Labor Standards Act of 1938, and the Family and Medical Leave Act of 1993 as they apply to the protection of state employees - restoring the right of state employees to sue the state for damages due to violations of these federal laws;
- Clarification regarding reasonable accommodation to enable a person with a disability to use and enjoy a dwelling - includes the use of an animal to alleviate the symptoms or effects of a disability;
- Emergency Preparedness legislation that requires every high-rise building owner to establish, maintain, and update an emergency evacuation plan for disabled occupants and visitors;
- Medical Equipment - requiring the Commissioner of Health to maintain specific reimbursement and billing procedures within Medicaid for these complex rehabilitation products and services;
- Tax Credits - Small Business Tax Credit for Employing People with Disabilities.

All of Us Includes Disability

Please join us for a presentation on the *All of Us* Research Program, which is a program from the National Institutes of Health (NIH). *All of Us* seeks to enroll "one million or more" participants in a longitudinal research cohort to improve our ability to prevent and treat disease based on individual differences in lifestyle, environment, and biological makeup, including genetics. The program aims to oversample communities that have been underrepresented in research to make it the largest, most diverse resource of its kind. People ages 18 and older, regardless of health status, are eligible to enroll, including people with disabilities. Come to our workshop to learn more about how you can be part of the program. The workshop will be held on June 20 from 1-3 pm at our Manhattan office.

All of Us Incluye la Discapacidad

Las personas de 18 años o más, independientemente de su estado de salud, son elegibles para inscribirse, incluyendo las personas con discapacidades. 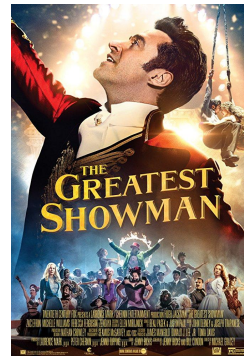
