

#### **Presidential Primary – April 28**

Here are the deadlines for registering to vote for the Presidential Primary. If you need help, you can fill in your registration forms at CIDNY offices and we will mail or deliver the registration forms for you.



- MAIL REGISTRATION must be postmarked by April 3, 2020, and received by April 8
- IN PERSON REGISTRATION must be received by April 3, 2020. You may register at your local board of elections or any state agency participating in the National Voter Registration Act.
- CHANGE OF ADDRESS must be received by April 8, 2020
- CHANGE OF ENROLLMENT (to change your party affiliation) must be received by the NYC Board of Elections no later than February 14, 2020

## Join CIDNY in Making 2020 Count for People with Disabilities

This year, there are threats to the safety net programs that many of us rely on to stay independent and living in the community. There are also threats to weaken the ADA. There are a couple of things we can all do right now to continue protecting our rights:

# People with Disabilities Count – the 2020 Census



The Census form will come online on Thursday, March 12. We are encouraging everyone to get counted. It will make a difference. Consider this: "affordable housing" prices are based on census data that reveals incomes of people living in New York City. If the majority of the people answering the Census are people who are upper middle class or upper income then "affordable" housing is based on that income. If people with disabilities aren't counted, then the need for more "accessible" housing may go unanswered.

The Census form will ask: how many people are living or staying at your home – their sex, age, race, and ethnicity. It will ask whether your home is owned or rented and what your home address is.

The Census <u>will not</u> ask: about your immigration or citizenship status, your income or your Social Security number. If someone says they are from the Census and asks these questions, <u>do not answer</u> them and do not continue the conversation with that person.

By law, your personal information is kept confidential. Your responses can be used only to produce statistics. They cannot be used for law enforcement or to determine your eligibility for government benefits.

### Federal Judge Issues Ruling on Lawsuit over Inaccessible Policy Precincts

For years, CIDNY has monitored inaccessibility at police precincts and CIDNY staff and board members joined a lawsuit.

The suit was brought by Disability Rights Advocates and Cravath,

Swaine & Moore LLP on behalf of organizational plaintiffs Disabled In Action of Metropolitan New York (DIA) and Brooklyn Center for Independence of the Disabled (BCID) and individual plaintiffs including Paula Wolff (former CIDNY staff), Jean Ryan, Edith Prentiss, and Dustin Jones (CIDNY Board member).

Federal Judge Caproni has issued a major ruling holding the New York City Police Department (NYPD) liable for discrimination against people with disabilities by shutting them out of police precincts.

The lawsuit charged that more than half of police stations across the city are physically inaccessible to people with mobility disabilities, preventing them from seeking refuge if they feel unsafe, making crime reports, attending public meetings, and accessing other crime prevention services.

Problems include architectural barriers, including stairs as the only way to reach front entrances and lifts that are regularly broken or have missing keys necessary for operation. When alternate routes exist, they are often unmarked and unsafe, with narrow paths, broken pavement and missing handrails.

The plaintiffs also showed that precinct houses include numerous accessibility barriers within the stations, including inaccessible bathrooms at nearly every station, heavy doors with narrow doorways, and insufficient clear floor space, among other barriers that block or impede access.

Judge Caproni's ruling noted that the NYPD has taken initial steps to address precinct inaccessibility during the course of this litigation, but the plan was developed solely by NYPD members without any input from the disability community.

The ruling requires that any remedy to the inaccessibility of precinct stations include the input of the disability community. The plaintiffs and the NYPD must meet and submit a joint letter by March 12, 2020, describing their efforts to reach a solution.




Image: clock showing setting time ahead one hour for Spring.
