Get the health care coverage you need now! You can enroll in or change plans if you have certain life events or income or qualify for Medicaid. For example, if you lost Medicaid coverage during the Medicaid Unwinding, you could qualify for Marketplace coverage. Visit healthcare.gov to see if you qualify.
