Paid Research Opportunity: Health Care Experiences Of Pregnant People With Intellectual And Developmental Disabilities

The Rubenstein Lab at Boston University School of Public Health is conducting a study called, Policies for Reproductive Outcomes in Medicaid—Improving Services for Enrollees with Intellectual and Developmental Disabilities (PROMISE-IDD). The goal of the research study is to understand the health care experiences of pregnant people with intellectual and developmental disabilities (IDD) to help improve the health care and health outcomes of pregnant people with IDD.

An eligible participant should:

- Have a documented IDD diagnosis
- Be 18 years of age or older
- Speak and understand English
- Be currently pregnant or have been pregnant in the past 10 years
- Have lived in the U.S. while pregnant
- Were enrolled in Medicaid during pregnancy

Selected participants will be interviewed for one to one and a half hours about their experience with pregnancy care. Participants will be provided with a \$50 Amazon visa gift card for their time.
